- (e) Evidence of current Industrial Training Fund (ITF) certificate in compliance with the provision of Industrial training Fund (ITF) valid till 31<sup>st</sup> December 2019.

- (g) Evidence of current Nigeria Social Insurance Trust Fund Compliance Certificate valid till 31<sup>st</sup> December 2019.
