The shortlisting criteria are:

- a) The Firm's general experience and overall competence, including the relevance of the firm's area of core business to the assignment envisaged;
- b) Firm's strong institutional capacity/capability in terms of technical, managerial, expertise, quality management system, and the number of technical staff.
- c) The extent of specific experience in assignments of similar nature and complexity in Smart Meters technology, management and supervision of supply and installation of smart meters, including review of design, supervision of contractor's quality, schedule, verification of equipment quality etc.
- d) Experience of the consultant in the supervision or implementation of Meter Data Management Systems for AMI deployment (including integration with HES and CIS applications)
