The Bid security is not in the format included in Section IV of the Bidding document and is valid for 119days against the required validity of 148days. The bid Security submitted is also not subjected to the Uniform Rules for Demand Guarantees (URDG) 2010 Revision, ICC Publication No. 758  The Bidder submitted a Bid Security

The Bid security is not in the format included in Section IV of the Bidding document and is valid for 115days against the required validity of 148days. The Bidder did not provide the delivery date/schedule of the equipment as required in the bidding document.		
MBH Power Limited	US\$9,084,286.46	The Bidder has not complied with the technical specifications and requirements of critical supply materials for this project for failing to provide the technical guarantee table for Circuit Breaker, 33kV, 25kA, 1250A.

The Bidder has not complied with the required technical specifications based on the information provided for these items.  Xian Electric Engineering Co. LTD has not complied with the technical specifications and requirements of critical supply materials for this project for not complying with the required parameters for Circuit Breaker, 33kV, 25kA, 1250A.
Limited		Breaker's breaking time and closing time of <70ms and <80ms respectively as against the required <40ms and <50ms respectively. The Evaluation committee views this as a major deviation considering that the 33kV Circuit Breaker is expected to have shorter breaking time than the 132kV Circuit Breaker, that is, to be able to break prior to the 132kV Circuit breaker. In view of this short coming, the bidder has not complied with the specification and requirement for this equipment.
